After each use: Rinse or spray the surface with cool (for best results), clean water. Wipe it dry or let the water drain off and pat dry the few remaining droplets.

<u>Once a week</u>: Wet the surface and use a nylon body puff and go over the wet surface, rubbing in a circular motion. You should feel places that are "sticky" going back to slick again. Then rinse or spray the surface with cool, clean water just as you do after each use. Wipe it dry or let the water drain off, and pat dry the few remaining droplets.
